Ventilation classes	Pupils Staff Others (visitors for academy events)	Infection control	<ul> <li>Identify any poorly ventilated spaces and take steps to improve fresh air flow</li> <li>If mechanical ventilation systems are used to draw fresh air or extract air from a room these should be adjusted to increase the ventilation rate wherever possible</li> <li>Ensure that mechanical ventilation systems only circulate fresh outside air and where this is not</li> </ul>	MED	<b>√</b>



			<ul> <li>possible, in a single room supplement with an outdoor air supply</li> <li>Where appropriate open external windows, internal doors and external doors to improve natural ventilation</li> <li>If external doors are opened, ensure that they are not fire doors and are safe to do so</li> <li>PE changing rooms without mechanical airflow or windows that can be opened to have doors open and 3/4 screens in place for privacy.</li> </ul>		
Overcrowding	Staff Pupils Others (visitors for academy events)	III Health	<ul> <li>Visitors enter via 3 different entrances to prevent overcrowding.</li> <li>One-way system in force in S and C blocks prevents overcrowding</li> <li>Guides will follow pre-determined routes across the school to avoid congestion in the main blocks</li> <li>Main Hall presentations replaced by pre-recorded presentation by Principal to visitors.</li> </ul>	MED	✓
Poor hygiene practice	Staff Pupils Others (visitors for academy events)	III Health	<ul> <li>You should continue to ensure that children, staff and visitors clean their hands regularly, this can be done with soap and water or hand sanitiser</li> <li>Staff and visitors are encouraged to wash their hands with soap or alcohol-based sanitiser (that contains no less than 60% alcohol) and follow infection control procedures in accordance with the DfE and PHE's guidance.</li> <li>Sufficient amounts of soap (or hand sanitiser where applicable), clean water and paper towels are supplied in all toilets and kitchen areas.</li> <li>Cleaners to carry out daily, thorough cleaning that follows national guidance and is compliant with the COSHH Policy and the Health and Safety Policy.</li> <li>A senior member of Estates staff arranges enhanced cleaning to be undertaken twice daily or more where</li> </ul>	MED	<b>√</b>



Classroom management	Pupils Staff	Infection control	<ul> <li>required – advice about enhanced cleaning protocols is sought from the HPT/PHE</li> <li>It is no longer required for forward facing tables etc however care should still be taken on table management in a classroom setting.</li> <li>Outbreak management plans should cover the possibility of reintroduction of restrictions on mixing for a temporary period in case of local outbreak.</li> <li>Academy will revert back to previous risk assessments and tighter control measures in the event of a local outbreak.</li> <li>Continue to use a cautious approach with arrangements.</li> <li>All classes will have robust seating plans that are up to date to assist with the management of cases (Satchell One; formerly SHMW).</li> </ul>	MED	✓
